INSTRUCTIONS FOR ABSTRACT SUBMISSION

Title – Be as brief and clear as possible. Do not use abbreviations or acronyms in the title. Contact Information – Please include your email as prompted by the submission system. Name(s) of Author(s) – Please provide the name of each author and their organization, city, country.

Abstract Text (must use the WORD template provided on INMIS website)

Please follow the structured format, indicating in bold the four parts of your abstract:

- Limit the text to 300 words (excluding title and authors) in English
- Use subtitles to mark the parts of the abstract;
 - Introduction/Background and Aim(s) provide the background to the problem/issue under investigation and the Aim(s) of the work
 - o Methods methods used to address the problem
 - o Results summarize the main results obtained
 - o Conclusions: the significance/impact of your findings which are supported by your results
- Please define all abbreviations and acronyms first time used. Place special or unusual abbreviations in parentheses after the full word the first time it appears.
- Each abstract must be complete (i.e. it must include all information necessary for its comprehension and not refer to another text by using phrases such as "...the data will be elaborated..."). The results section needs to be complete (i.e. "data analysis to follow" is not acceptable).
- One Data table or graph is permitted, but should be brief. Each table/graph will count as 50 words against the 300 word limit.
- Use generic names of drugs

The presenting author is responsible for ensuring that all co-authors have approved the content of the abstract prior to submission to INMIS 2019.

Abstract category (select the most appropriate category for your abstract on the submission platform):

- 1. Pre-clinical: including vaccine development and laboratory science
- 2. *Clinical:* including methodology, epidemiology of vaccine preventable diseases, Phase I-IV clinical trials, prevention of disease transmission, vaccine safety and impact of the microbiome;
- 3. *Programmatic:* including vaccine implementation, vaccine acceptance and hesitancy, ethics, economics, modelling, program evaluation, vaccine coverage, post-marketing surveillance, disease impact.

Indicate if you would like your abstract to be consider for oral or poster. Preference for method of presentation of abstract will be accommodated when possible but cannot be guaranteed.

Disclosure of all financial relationships that the author has with the manufacturer/supplier of any commercial products or services **related to the work presented in this abstract** must be indicated on the abstract submission form. All abstracts will be reviewed via the same process irrespective of these disclosures.
